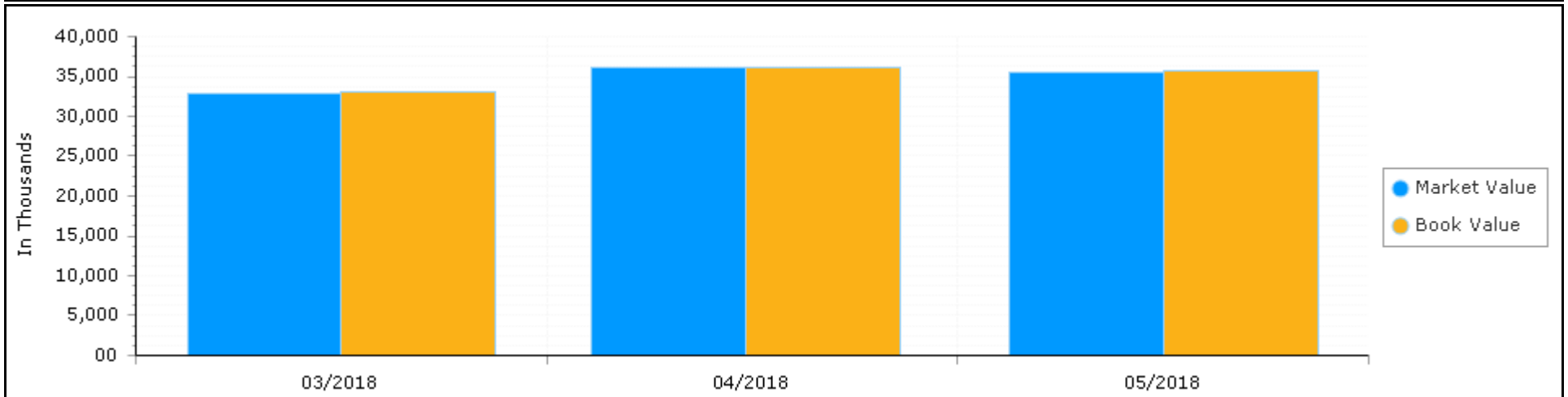

Odessa College Distribution by Asset Class - Market Value

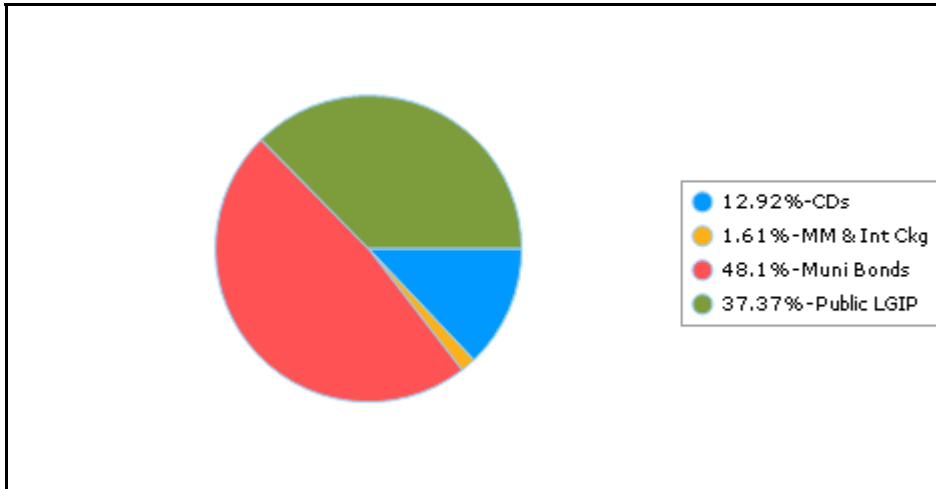

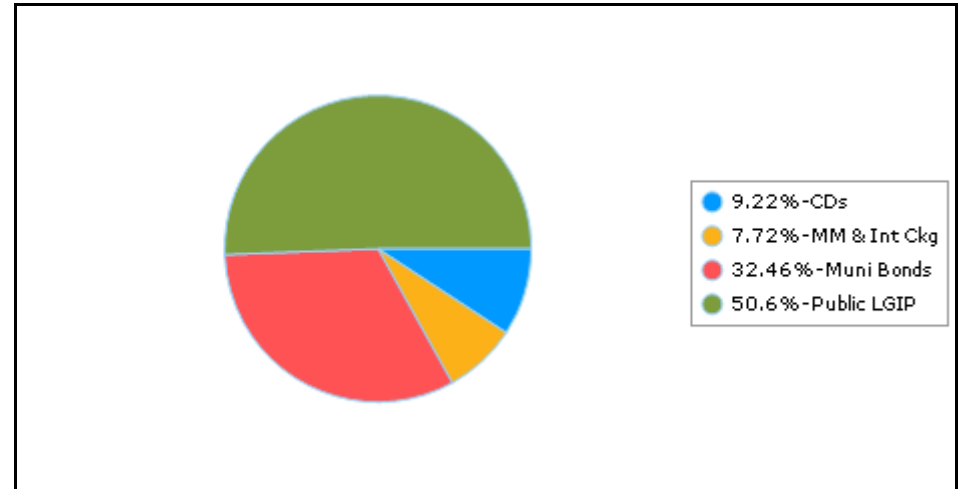

Odessa College Distribution by Asset Class - Market Value

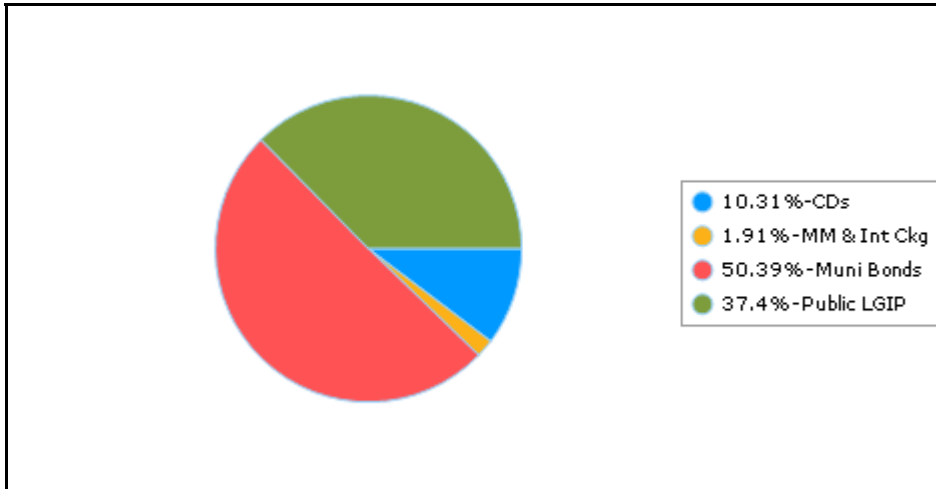

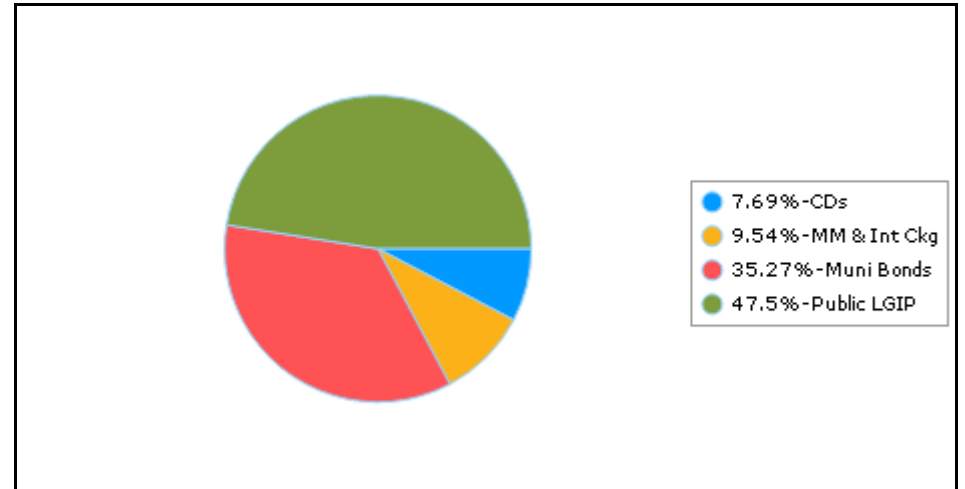

Odessa College Distribution by Asset Class - Market Value

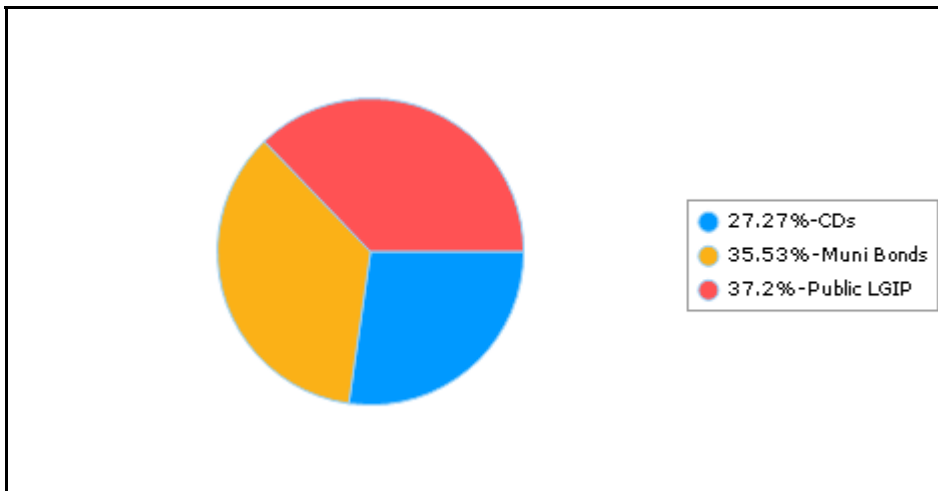

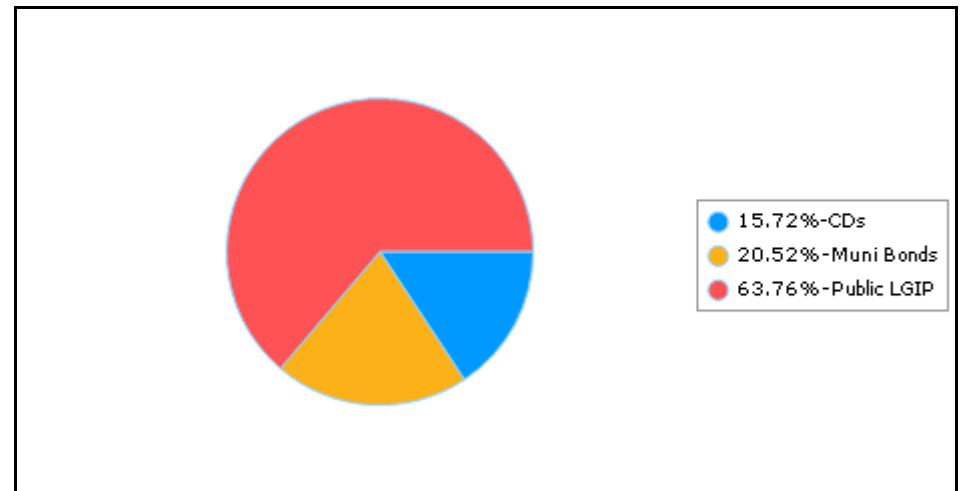

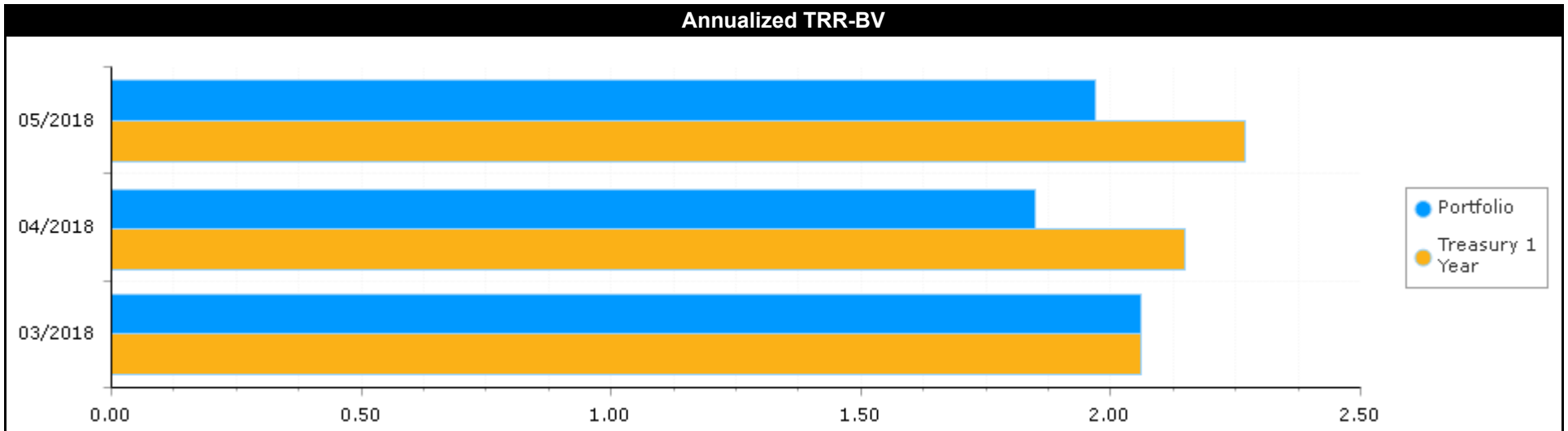

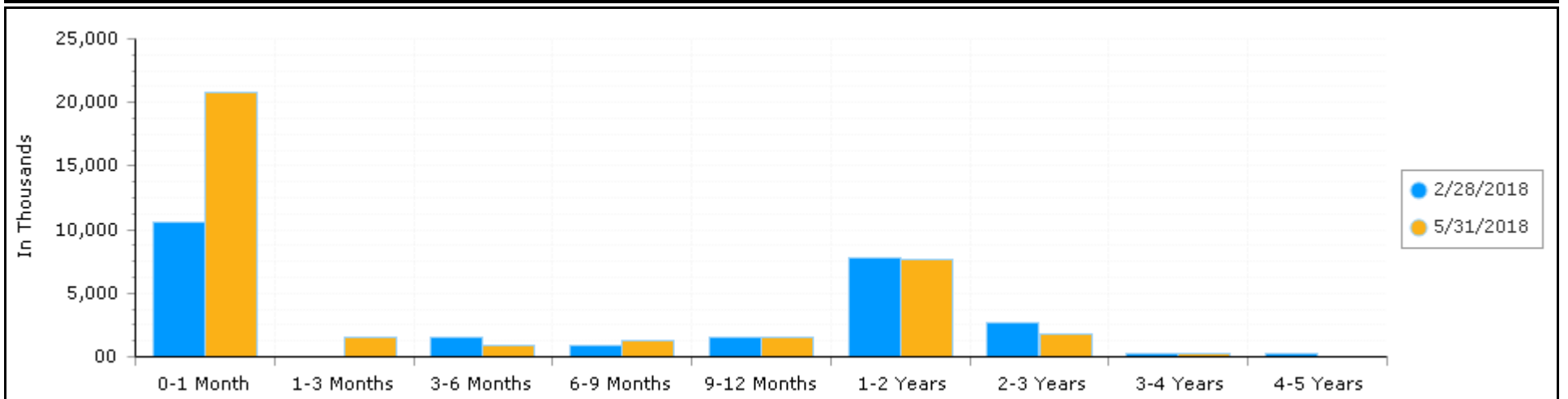
