## Continuing Education (CE) FAQs

### Are there any special requirements to register for CE classes?

Some CE classes do have special requirements, and, therefore, you must register in person.

### How are CE classes different than credit classes?

CE classes differ in four primary ways.

1. While some classes may have some requirements to fulfill prior to registering, you do not have to apply to the college in order to enroll.
2. Our classes start throughout the year, rather than set times during a college semester.
3. Our classes are generally fast-track, meaning that they are shorter in length in order to accommodate your schedule and your need for skills you can use immediately.
4. For classes that you successfully complete, you will receive a certificate of completion and in many cases you will also be awarded Continuing Education Units.

### What is a CEU?

A CEU (Continuing Education Unit) is 10 contact hours of participation in an organized, non-credit continuing education experience. Therefore, one CEU is awarded for every 10 hours of training completed.

### When should I register?

Registration for CE classes begins when classes are published online or in print. Registration continues up until the first day of class for most courses or until the class fills. Early registration is encouraged as some classes fill quickly. Classes may be cancelled if minimum enrollment is not met.

### How do I pay for a class?

Payment is due upon registration. If a student wishes to set up as Payment Plan for their course, they have 24 hours after registering to do so or they will be un-enrolled and removed from the class. Students may pay in person by Cash, check. Credit/debit card, or by phone using a debit/ credit card. Students who enroll by email or fax will be called after enrollment to allow them to pay for the class in full or set up a payment plan with Student Accounts. Some tuition assistance is available through CE Scholarships and Workforce Solutions of the Permian Basin for those who qualify. Call 432-335-6580 for more information.

### How am I notified if a class is cancelled?

There are two primary ways—by phone and by email. Therefore, it is very important that in filling out your registration form, you list a current phone number and email that you check frequently.

### What about a refund for a class that cancels or that I do not attend?

Classes are subject to change without notice. For classes/ programs cancelled by the college, the college will refund 100 percent. To receive a refund for classes you do not attend, you must submit a Drop Form prior to the class starting. For withdrawals, the college will refund 100 percent if the Drop Form is received three or more business days prior to class start. Additionally, for classes/programs meeting 65 hours or more, the college will refund 75 percent if the Drop Form is received less than three business days prior to class/programs start and prior to the 3rd class meeting. No refunds will be given thereafter. Refunds will be issued by check in 10-14 business days.

### What if there is inclement weather?

In the event of inclement weather, visit the Odessa College website at [www.odessa.edu](http://www.odessa.edu) for closure information.

### What about parking?

When you register, you will receive further direction on whether additional parking passes may be required. Parking in the Continuing Education parking lot is open and does not require a pass (NOTE: Employee Parking is designated by blue lines).

## Refund Policy

For classes cancelled by the college, the college will refund 100 percent. For withdrawals, the college will refund 100 percent if Drop Form is received up to three business days prior to class/program start.

Additionally, for classes/programs meeting 65 hours or more, the college will refund 75 percent if the Drop Form is received less than three business days prior to class start and prior to the 3rd class meeting.

No refunds will be given thereafter. Students may withdraw from a class by completing and signing the Drop portion of the Registration Form and delivering it to the CE Office in person, by email, or by FAX.

## Payment Plans

Payment plans are available for most programs. Students who wish to use this option will need to inform Continuing Education at enrollment. They will be instructed then on how to proceed with Student Accounts. An Enrollment Fee that will not exceed \$30 is required at that time.

# TRUCK DRIVING ACADEMY



**Classes: Monday-Thursday: 7:30am-5:30pm and Friday: 8am-1pm**

According to American Trucking Association, over half a million drivers are needed each year for the next decade. With the growth of the Transportation Industry, there is a high demand for professional truck drivers.

Odessa College offers a five-week course of classroom instruction, basic street driving, and application of skills used in the operation of a tractor-trailer. Starting salaries for long-distance professional truck drivers can average \$45,000 per year.

Our classes, which consist of up to 200 hours, include classroom and behind-the-wheel instruction, as well as screening to help qualify our trained drivers for employment. Students who successfully complete the entire course will receive a certificate of completion and be qualified to secure an entry-level job as a Commercial Motor Vehicle driver.

Odessa College does not guarantee that the Texas Department of Public Safety will issue a license. Students will have up to 200 hours of training and will have the opportunity to talk with visiting recruiters for possible employment.

**COST:**

Applicants for the program must successfully complete a pre-employment screening (fee is included in tuition) which includes Department of Transportation physical, drug screen, moving violation report and CDL application. The total cost of this program is \$4,150.

**REQUIREMENTS:**

Applicants must have a high school diploma, GED, or pass an assessment test and must be 18 years of age or older.

# Safety and Rescue Training

Courses require a minimum of six candidates, who must be in good physical condition and have an aptitude for working at heights. Specific equipment will be needed for some courses. Courses are based on the written curriculum of Rescue Training International.



## Industrial Rope Rescue Technician

This 50-hour course covers the two-rope rescue system, including fixed rope, top and bottom rope belay systems, redirecting anchors, pickoffs, mechanical advantage systems, ascending and descending past knots, mid-line transfers (aid climb rescues), Tripod and A-Frame Operations, patient packaging, troubleshooting on ropes and diagonal tension lines.

## Confined Space Rescue Technician

A 60-hour course from Rescue Training International designed for those personnel who may enter a confined space for rescue operations. This course covers the planning, hazard mediation and execution of confined space rescues in horizontal and vertical vessels. Attendees also will receive training as a Rope Rescue – Operations Level Technician and Confined Space Authorized Entrant as mandated by OSHA regulations and the NFPA 1006, Chapter 7.2.

## Confined Space Rescue – Horizontal Rescue Only

A one-day course covering the provisions of the NFPA 1006, Sections 7.2.9 through 7.2.11. This course satisfies the requirements for the Tier 2 System rating of Occidental Petroleum.

## Vertical Rescue Technician – Level 1 (No Prerequisite)

A 20-hour Basic Level course for Fire Department personnel, the VRT1 course covers basic rappelling, ascending, rescue rigging and equipment needed in rescue operations.

## Vertical Rescue Technician – Level 2 (Prerequisite VRT1)

A 20-hour Intermediate Level course for Fire Departments, the VRT2 course covers Access, Stabilize and quick Transport. Topics include double rope belays, mechanical advantage, ascending changeover, victim harnesses, advanced anchors, rescue baskets, patient packaging, load releasing hitches, slope evacuations, night skills and knot passing on line.

## Vertical Rescue Technician – Level 3 (Prerequisite VRT 2)

A 20-hour Advanced Level course for Fire Departments, the VRT3 course covers Stabilize and Transport of the more substantial injured, haul systems, vertical rescue baskets, high line options, patient /rescuer on line and advanced scenarios.

## Window Washer Technician Course – Basic (Prerequisite – None)

A 10-hour course from Rescue Training International for those who may provide cleaning and maintenance services while working at heights. This course only certifies the attendee for window wishing job assignments and covers self-rescue procedures only.

## Working at Heights

A 50-hour course designed for those who may work at heights for painting, inspections, installations and other work assignments while on rope systems, and includes rescue techniques: Two Rope Systems, JSA / Risk Assessments, Ascending, Descending, Re-Belays, Deviations and Rope to Rope Transfers and Pickoffs of a Suspended Person. On the final day, skills evaluations are completed based on scenarios given by the Instructor.

## Working at Heights Rescue the Rescuer (Prerequisite – Working at Heights)

Additional 30-hour course designed for rescuing a fellow rescuer through ropes systems that are constructed, such as Re-Belays, Rope-to-Rope Transfers and Deviations.

## Community Basic Rappelling (Prerequisite: 18 or over, 130-310 pounds, good physical condition)

An eight-hour community oriented course for members of the general public to learn the basic elements of rappelling. Knots, equipment and rigging of rope systems are completed in the morning, then after lunch attendees spend the day rappelling off the campus Rappel Tower on multiple devices. No more than four attendees, and attendees must provide their own certified safety helmet and gloves.

To be accepted into the OC-LETA, candidates must:



- Possess High School Diploma, (or G.E.D.)
- Be 21 before graduation from the Academy
- Be a United States citizen
- Currently not be and never have been on court-ordered community supervision or probation for any criminal offense above a Class B Misdemeanor within the last 10 years
- Not be currently under indictment for any criminal offense
- Never have been convicted of any family violence offense
- Not be prohibited by state or federal law from operating a motor vehicle
- Not be prohibited by state or federal law from possessing firearms or ammunition
- Never have been convicted of, pled guilty to, or received court-ordered probation, nor have received a deferred, adjudicated, or un-adjudicated sentence for any felony offense
- Not have been discharged from military service under less than honorable conditions

**As part of our Continuing Education Program, Odessa College offers a range of Health Career courses, taught by qualified professionals in both the classroom and clinical settings.**

### **Are there any requirements before I start class or clinicals?**

To protect our student's health and the health of patients, OC Continuing Education has a few requirements that must be met at the time of registration. All Health Careers students must meet industry standards in these areas to assure that, upon successful completion of the program, students will be employable in the highly-regulated healthcare industry.

In response to COVID-19, the Health Careers Pre-Registration process has been moved to a Document Tracking Service called COMPLIO! The Bundle package includes the required Document Tracking, Background Check, and Drug Screen costs required for enrollment in a Continuing Education Health Careers courses. This pre-registration service will cost \$95 for Odessa residents and \$107 for students in Extension Sites. Checklists as well a COMPLIO Student User Guide indicating the required documentation is available on the Continuing Education Health Careers program website which can be accessed through the QR Code below. Please review COMPLIO's refund policy prior to purchase. Students will need to be compliant in the American DataBank Complio system to enroll in a Health Careers course.

### **Do I need to pass any tests before I register?**

In addition to the above, students are required to provide a copy of their TSI results and should score 342 or higher. Equivalents to the TSI will be accepted. Some programs may need a GED to meet licensing requirements. This program requires students have completed a current hands-on CPR course, Basic Life Support (BLS) for Healthcare Providers (HCP) preferred.

### **Do I have any costs outside of tuition?**

Tuition costs are noted with each program. In addition to the tuition costs, students will be responsible for obtaining compliance in the American DataBank Complio system. This pre-registration service will cost \$95 for Odessa residents and \$107 for students in Extension Sites. The Bundle package includes the required Document Tracking, Background Check, and Drug Screen costs required for enrollment in a Continuing Education Health Careers course.

Textbooks, eBooks, or digital course content, uniform(s), travel costs, TSI Reading test, CPR course, health insurance, immunizations, and professional equipment may be required outside of the cost of tuition. The Health Careers program specific website will indicate these requirements. Additionally, students will be notified at registration.

***Required textbooks, eBooks, and digital course content are available at the Odessa College Campus Bookstore (432) 335-6654 and through online distributed learning content. Please refer to the textbook list on the Health Careers website for more information.***

### **What happens after I finish the program?**

Course completion does not guarantee state or national certification or licensure as this is governed by outside agencies. If you successfully complete the program with a grade of 70% or higher, you will receive a certificate of completion from Odessa College. A digital Certificate of Completion will uploaded to the students COMPLIO account when the student has completed all Health Careers programs requirements.

### **How do I register?**

***The current process for registration is as follows:***

- After becoming compliant in the COMPLIO system, the student will call CE at (432) 335-6580 to enroll.
- Register for the desired Health Careers PROGRAM
- Pay for the selected PROGRAM and Course Fees, or make payment arrangements. Some scholarships are available AND must be requested at registration. You will need to provide a copy of your W2 with the scholarship application.
- Once payment or payment arrangement has been established, you will receive course-related information from a Continuing Education Customer Service Representative.

# CONTINUING EDUCATION **CPR**

Lifesaving skills of respiratory and cardiac emergencies involving all people.

Designed to be repeated multiple times to improve proficiency for healthcare providers and professional rescuers.



Odessa College is a designated American Heart Association (AHA) Training Center. The Basic Life Support for Health Care Providers (BLS HCP) course is specifically for healthcare providers and professional rescuers. The four-hour class will cover Cardio Pulmonary Resuscitation (CPR) and the Automated External Defibrillator (AED). Additionally, this course will provide students with life savings skills not only for adults but for children and infants.

You must be at least 9 years old to take the course. A parent must be present in the building for all non-Odessa College students under the age of 16 years. The parent may not assist the student in the written or skills assessments. Children not enrolled in a class will not be admitted. The CPR class and exam are administered in English. Students may be able to bring a translator to the class with prior approval from the director.

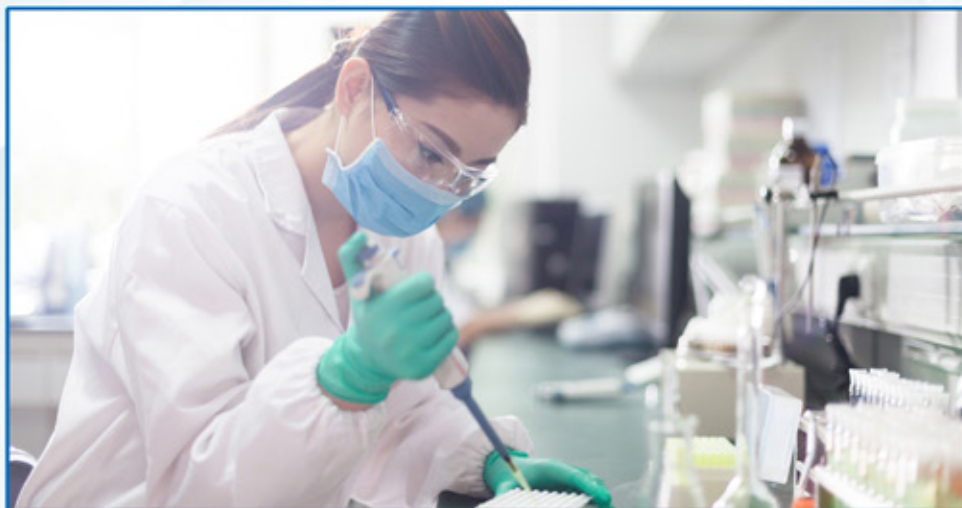

### **TxCHSE (Formerly GED)**

The Odessa College Adult Education and Literacy Program provides several services for students in the community. The instruction is geared for students to pass the TxCHSE test (formerly GED), which covers reading/writing, science, social studies, and math.

*Students can choose one of three pathways:*

- Fast and Focused I: GED Preparation in 30 days
- Fast and Focused II: GED Preparation in 90 days (16, 17, 18 year-old students only)
- Fast and Focused III: GED Preparation in 16 weeks

Additionally, for students interested in enrollment in college courses, an additional pathway is available while also earning a GED. Also, students interested in gaining employment skills have the opportunity to enroll in a skills class that is offered through the AEL program. All AEL programs are offered free of charge to Adult Education and Literacy students who meet the requirements.

# ADULT EDUCATION —AND— LITERACY

English as a Second Language (ESL)

The Odessa College Transitional Learning Center ESL program is designed to assist adults who want to learn the English language at no cost to the student.

The Transitional Learning Center ESL program is unique because students are assigned to a class with others who are at the same English-speaking ability level.

Students are placed into classes based on two tests administered prior to their enrollment.

The tests assess both English speaking/listening and reading/writing language skills.

Students take both tests in order to determine their classroom assignment.

There are six levels of English instruction in this program.

When students master their current level, they will advance to the next level.

To register, students must visit the Transitional Learning Center during registration and schedule an appointment for testing.

The Transitional Learning Center offers integrated education and training programs (IET).

This programming allows English Language Learners to develop employable skills while receiving English language support.

Several programs have been selected for students to participate in.

All ESL classes are FREE to community members age 19 and up. Persons under the age of 19 must show proof of high school completion.

Official Photo ID and Social Security Card (if one has been issued to you) are required in order to register.

Students must plan to attend the first week of classes without missing any time and must attend classes for 60 hours or more to complete a progress test.
